**48th Tri-State Telecom Operations Conference
(TOC) & Showcase & Golf**

The TOC Golf Outing will be held on Monday, May 10 at the Moorhead Country Club, Moorhead, Minnesota. The TOC Conference and Showcase will be held May 11 –13 at the Holiday Inn, 3803 13th Avenue South, Fargo, North Dakota.

Management, plant, and office personnel from North Dakota, South Dakota, and Minnesota telecommunications companies attend the conference each year. Telephone companies from neighboring states also attend. Total attendance is generally between 900-1,000 people, which includes supplier company personnel. The conference is known for its timely seminars and packed exhibitor Showcase.

Donna Thiel at Red River Telephone will coordinate the golf outing. Golf registration and golf fees are to be mailed directly to **TOC Golf Outing, Red River Telephone, P.O. Box 136, Abercrombie, N.D. 58001**. You **MUST** be registered for the TOC Conference to participate in the golf outing. Retirees are exempt from the rule. Showcase exhibit space is limited and fills up fast. We have 114 spaces available. Exhibits will be in the Great Hall and pool courtyard area. You have the choice of an 8' wide space (for tabletop displays), 10' wide or 16' wide space. We encourage suppliers to limit the number of booth spaces to two spaces (center divider will be removed).

Your company name, contact information and product/service information will be printed in the "supplier" section of the program. Please complete the registration form and return it as soon as possible to guarantee exhibit space. If you want to pay from an invoice, indicate so on the form and an invoice will be emailed to you. When mailing your check for registration fees, make the check payable to "**NDTA**" (or "**TOC**"). **We do not accept credit cards.** If you fax or email your registration form to NDTA, you must follow up with payment within thirty days or less to guarantee your space. Only companies with paid registrations will be assigned exhibit space. Unpaid registrations for exhibit space will be null after April 2 and the exhibit space will be given to a company on the waiting list. No exceptions will be made. Exhibit-space fees and non-exhibiting fees are non-refundable after April 10. Per-person registration fees are non-refundable after April 23.
